

Face Painting Booking Agreement

FEES:

- My fees are charged at £50 per hour (minimum 2 hour booking) I will arrive approximately 20 mins before the start of the event to set up in order to start painting at the required time.
- I can paint approximately 12 faces per-hour depending on the difficulty of the designs that are chosen. Be sure to book your time accordingly to avoid leaving anyone out.
- I may have events booked after yours and I may not be able to stay past time contracted hours. If you exceed the time booked and I am able to stay, I will charge in half hour increments (£20). Client will pay for the time booked plus overrun, even if the client has delayed the time I start the actual painting.
- All outstanding charges are due on the day of the event. Client must pay for a minimum of 2 hours even if the client uses me for less than that.
- Once you have paid the deposit your date and time slot will be held.

TRAVEL:

- Travel fees apply at £1.00/per mile if the event is farther than 20 miles away from Enfield N9

INDOOR SET UP:

- I need a minimum of a 6'X6' space to set up with adequate lighting. Please let me know if I need to supply a table and chair.
- I will need to arrive approximately 20 mins before the start of the event to set up. This is included within the price. Please let me know if there are any issues with this.

WEATHER: (For outdoor events)

- The client agrees to provide an area protected from excessive wind, rain and snow.
- Client is responsible to provide an alternate indoor location in the event of inclement weather.
- The client agrees to pay for the full amount contracted once I arrived at the event location, even if it is raining. I do not give refunds for inclement weather.

CANCELLATIONS/REFUNDS/RESCHEDULE:

- Should you need to reschedule your event, please do so at least 7 days prior and I will make every effort to meet your needs.
- The deposit is non-refundable if the client cancels the event.
- Refunds are not given for inclement weather so please secure an alternative indoor location for your event in advance.
- Should I get sick, have symptoms of Covid 19 or have to cancel, your deposit will be refunded. I will do my best to provide details of alternative painters.
- If the client needs to cancel due to illness (including Covid 19) I will be happy to rebook for the event.



EXTREME ADVERSE WORKING CONDITIONS:

- I have the right to cease painting and leave without refunding any monies if there are extreme adverse working conditions and the client fails to remedy the situation after it has been brought to the client's attention.
- Adverse conditions include but not limited to: Destruction, Violence, or extreme inappropriate behavior of a child/pet/adult, illegal activities, or otherwise dangerous conditions.

PICTURES:

- Photos will not be taken or used without parental/guardian consent.
- Any photos taken will be used for promotional purposes only and identities will never be revealed.

LIABILITY STATEMENT:

- While I only use FDA approved cosmetic grade face painting supplies, I am not liable for allergic reactions to paints. People with skin allergies or sensitive skin should either not participate, or have me do a patch test at the beginning of the event.
- Some face paints may linger and can be removed with mild soap, water, and washcloth.
- For safety reasons I will not paint the faces of children under 2 years of age, I can offer a small hand or arm design where appropriate.
- I will not paint any children who do not want to be painted.
- For sanitary reasons I will not paint anyone who appears to be sick, or suffering from cold sores, Covid 19 symptoms, conjunctivitis, ringworm, any infectious conditions or open wounds. These determinations are at my discretion.
- I will use reasonable care, but am not responsible for damaged clothes or property.
- The client agrees to pay for any accidents, injuries, and/or damage to my equipment or supplies caused by pets or guests.
- Under no circumstances will I supervise children. Their behavior and safety is the client's and/or parents responsibility.

Payment:

By paying the deposit and signing this contract I agree that I have read, understand and accept the Liability Statements on Face Painting, as well as the terms of this agreement. I agree to pay the stated deposit and pay the balance of the amount by cash, or PayPal no later than the day of the event
